# St. Matthew's July 2025 Vestry Meeting Minutes Approved at August Meeting July 10, 2025

Call to order: 5:31 p.m.

Quorum established.

Agenda Approval: Allen Todd moved to accept the agenda. Maggie Castellini seconded. Passed unanimously.

Finance Report: Allen Todd gave finance report.

Eliza Winfrey joined meeting in person during finance report.

We are a little over half way through the year and have nearly reached our \$10,000 fundraising goal. We are only about \$75 short of that goal.

Lorraine David made motion to accept finance report. Val Adams seconded. Passed unanimously.

Approval of June 12, 2025 Meeting Minutes

Allen Todd made a motion to accept the last meeting minutes with the changes of adding Lorraine David to the absent list. She was on travel. Also on page 3 under Diocesan Convention: correct the spelling of "on" Lorraine David seconded. Passed unanimously.

Parish Administrator Report: Read by Val

Air Filters: Subscribe & Save OR One Time Purchase

Lorraine David made a motion to purchase air filters "Subscribe & Save 40%." Maggie Castellini seconded. Passed Unanimously.

Maggie Castellini would like to have the air purifiers mounted on the walls. When the air purifiers are sitting on the window sills, people tend to reach over and turn them off due to their noise. No one objected. Maggie C. will ask her husband Mike Castellini if he can help with getting them mounted.

Bread Line Request to Borrow Tables:

Val Adams thinks we need a policy NOT to lend our tables to individuals. In the past they were returned dirty and damaged and sometimes we would be missing tables & chairs. Maggie Castellini made a motion to NOT lend tables to "individuals." Val Adams seconded. Passed unanimously.

Lorraine David made a motion to lend tables to the Bread Line this time and St Matthew's needs to develop a policy and take a deposit on lending our tables & chairs out to organizations in the future. Also before the tables go out the door "St Matthew's Church" needs to be written on each table with permanent marker. Allen Todd seconded. Passed unanimously.

### **Convention Discussions:**

Fr. Steve let the vestry know that "Workspace's" can be removed from the list as it will take too long to shuttle people to and from. Also, there is no longer need to reach out to our neighbors, the Methodist Church.

The following vestry members offered to help during Convention.

Val volunteers to help where needed on Saturday.

Joanne volunteered to help with driving, cleaning & helping in the kitchen.

Eliza offered to help. Also Tom said Bonnie Marsh would be helping as well.

Other Ideas: Native dancing & singing during convention. Maybe the Stevens Village dance group. Also during Thursday service during convention maybe the Takudh singers can sing.

Fr. Steve said that St. Jude offered to do hamburgers and hot dogs one day of clergy conference. Diana Childs has done convention before and is very knowledgeable in that area.

# St. Matthew's Vestry Meeting Minutes August 14, 2025

Agenda Approval: Val Adams moved to accept the agenda. Maggie Castellini

seconded. Passed unanimously.

Finance Report: Brad Johnson gave finance report.

Val Adams made a motion to move \$20,000, after tithe, from the Moody bequest to the operating fund. Maggie Castellini seconded. Passed unanimously.

Val Adams made a motion to move \$200,000 from the money market to the 6-month cd account (1080) that now has a 3.1 rate. Maggie Castellini seconded. Passed unanimously.

Vestry members had questions regarding why Office 65150 (under expenses) was so high. Brad said that there has been a \$500 annual increase in Quickbooks. Also a big part of it is the cell phones, land line and internet 65109 and computer hardware & software 6515. Brad provided an itemized breakdown of Operating Income & Expenses.

Maggie Castellini moved to accept finance report. Tom Marsh seconded. Passed unanimously.

#### Approval of July 10, 2025 Meeting Minutes

Tom Marsh made a motion to accept the last meeting minutes. Maggie Castellini seconded. Passed unanimously.

**New Accounting Computer** 

Val made a motion to purchase a new tower/hard drive for the accounting computer from Costco for \$499.99. Linda Demientieff seconded. Passed unanimously. Downloading Facebook Lives

Kaylee is downloading all (Facebook) live-streaming to Podcasts & YouTube because FB automatically deletes them after 30 days.

Senior Warden Report: Tom said he had no report

**Rector Report:** Fr. Reed gave his report.

<u>Eval Form</u>: Fr. Reed distributed an evaluation form at the last meeting. He would like the vestry to please go over it by the next meeting.

Fish Fry: Did not work out for July but the hot dog/bake sale did.

St Matthew's an outlet for food boxes for Food Bank:

How this would work is that we would need someone in office to answer the phones for two hours on Friday mornings. People wanting these food boxes would call into the church giving their information i.e. how many people are in their household, if they are homeless, etc. St Matthew's would call this info into the Food Bank. The Food Bank would pack food boxes according to this information (family size, etc.) and deliver the boxes to St Matthew's. St Matthew's would then hand the boxes out when people come in to claim their food boxes.

A concern with this is that Kaylee doesn't work Friday mornings so help/volunteers are needed to answer phone calls and take the info to pass along to the food bank. Maureen Mayo and Linda Demientieff volunteered.

The vestry feels a schedule needed for volunteer sign up to help take food box orders.

<u>Billie out of town</u> Fr. Steve said Billie will be gone next March for 6 months.

<u>Discretionary Fund Policy & Eval. Form:</u> Fr. Steve handed these out for the vestry to review at the July Vestry meeting. He asked the vestry to please review this for the next meeting in September.

**Executive Session:** One item was discussed in executive session.

**Building**: I have not heard anything more from Bishop Mark or Lang about redevelopment and fundraising for a new Parish Hall.

**Fundraiser Idea**: Fish Fry didn't work, but the bake sale & hot dogs did.

**Newsletter**: We are working on a July / August 2025 Newsletter.

**Opportunities:** Bone Builders & Food Bank Food Box Distribution. Food box distribution consists of taking orders from families from 10:00 am to Noon, calling those orders into the Food Bank, where they would assemble a food box for each family. The boxes would then be delivered to St. Matthews for distribution Friday afternoon. Families would be coming here to pick up their Food Box. The challenge here is having someone to take calls / orders on Friday from 10am – Noon and assisting with moving the food boxes into the parish hall.

**Host Site**: We will be hosting the 2025 Clergy Conference & Diocesan Convention. Our next meeting is on Monday August 25<sup>th</sup> at 1pm. Who will chair subcommittees? Billy is chairing the meal prep subcommittee. We need a chair for the following: Tech Support; set up / cleanup; worship; and transportation.

**Parish Hall TVs**: Thank You card to Jackie Bloom's son-in-law Cliff. He was the driving force in getting the three 75" TVs and three outlets installed in the Parish Hall. The TVs, outlets, cables, and labor were all donated. Each tv is plugged into a surge protected power strip. Each strip is turned off during the week, except for funerals and Sunday morning worship. People regularly attend service in the Parish Hall and we bring communion.

**Clergy Discretionary Policy:** I distributed a clergy discretionary policy your review and vote.

Rector's Article for Summer 2025 Newsletter

Dear People of St. Matthew's Episcopal Church,

A year ago, I was called to be your rector. It has been quite a year with a remarkable series of events. Time has quite literally flown by. We have been witness to numerous services including Sunday Worship, baptisms, funerals, daily office, services and visits at FMH and Pioneer Home, and even a wedding. I have been honored to be joined at the altar by clergy from across the interior and our Bishop. We will host Clergy Conference and the Diocesan Convention the first week of October.

Last October we celebrated our 120<sup>th</sup> birthday as a church by hearing stories and memories from many members in attendance at the October 16, 2024, service.

We returned to providing Newsletters starting in May of this year with the goal of transparency by getting you a calendar of upcoming events, unofficial Vestry meeting minutes, my report to vestry, Kaylee's report, and occasionally guest columnists such as Helen Howard with her report from the Interior Deanery. The survey below is part of the visioning work for the future. We have been in discussions about a new roof or a new building. People have stepped forward to donate towards a new building, I invite you to dream a little about what you would like to see in a new Parish Hall. To be clear, we are not talking about making any changes to the sanctuary.
